

RATING OUR VICE PRESIDENTS

The paucity of ratings of vice presidents-contrasted with the wealth of data on presidents-makes comparisons of them difficult. Pulling together what data are available, the following five pages offer a basis for analyzing our vice presidents.




Two vice presidents turned president—Nixon and Bush—garnered some of the highest ratings, particularly toward the end of their respective terms as vice president.




Quayle and His Predecessors

Well into the third year of his term as vice president, Dan Quayle curries less public favor than his predecessor did during a roughly comparable time period.

Question: How would you rate the job Vice President... is doing as Vice President—excellent, pretty good, only fair, or poor? (Harris) What kind of job do you think George Bush is doing as Vice President? (NBC/WSJ) Considering everything, how would you rate the job that Dan Quayle is doing as Vice President? (ABC/WP)



Opinion of Dan Quayle



Regardless of who you support, please tell me if you think each person is basically qualified or not qualified to be President of the United States, or if, perhaps, you don't know enough about that person to say. 




President Quayle?

Question: Is having Dan Quayle as vice president something that worries you or not?









